## CALL FOR SUBMISSIONS

An exhibition and sale of miniature art  
by regional artists

July 1 to August 31, 2018

The Tom Thomson Art Gallery Shop is organizing an Exhibition and Sale of **100 Squares** beginning July 1, 2018. This year's theme, *Tom Thomson Country*, speaks to the beauty of the great Canadian landscape views which inspired Tom Thomson and his work. Please use this theme as a guideline for creating your square(s). The Gallery Shop is seeking submissions from regional artists who are interested in contributing miniature works in any medium. One 100mm (10cm x 10cm x 10cm) square area of wall space is available to the first one hundred artists to register. The show is non-juried; however, the Gallery reserves the right to decline work at its discretion. The works will be for sale through the Gallery Shop.

### SUBMISSION GUIDELINES

- Two-dimensional and three-dimensional works in all media will be accepted.
- Artworks must not exceed 10cm H x 10cm W x 10cm D including support or frame.
- All work must be ready to hang.
- Artists can submit up to five works each, but please note that all five works may not be shown at once. Each of the 100 square spaces will be assigned according to number of artists participating. As artwork is sold, new pieces will be installed to fill the gaps.
- All **100 Squares** must be for sale on consignment. Artists will receive 60% of the selling price.
- Artists are responsible for delivering **100 Squares** artwork(s), along with the completed submission form to the TOM on or before deadline of June 10, 2018.
- All Artists are required to fill out an EFT form (Electronic Funds Transfer) form for payout processes. This form is attached to the submission form.
- Artists are responsible for picking up any unsold work at the conclusion of the sale. The Tom Thomson Art Gallery assumes ownership of any unclaimed artwork.
- Purchasers of '**100 Squares – Tom Thomson Country**' work will be able to remove their purchase at the time of sale.
- Gallery will issue payment to the Artist for work sold during the sale within its regular consignment payment schedule.
