**Declaration of Qualifications  
School Board Candidates**

*Municipal Elections Act, 1996*

I, \_\_\_\_\_, being a candidate for the office of:

- Bluewater District School Board Trustee – English Public
- Bruce Grey Catholic District School Board Trustee – English Separate

**Do solemnly declare that:**

1. Pursuant to the provisions of the *Municipal Elections Act, 1996*, the *Municipal Act, 2001*, and the *Education Act*, I am qualified to hold the office of Trustee for the above-noted School Board.
2. Without limiting the generality of paragraph 1, I am a resident of the area of jurisdiction of the School Board, a Canadian citizen and at least eighteen years of age.
3. I am not ineligible or disqualified under the *Municipal Elections Act, 1996*, the *Municipal Act, 2001*, the *Municipal Conflict of Interest Act*, the *Education Act*, or any other Act, to be elected to or hold the above-mentioned office.
4. Without limiting the generality of paragraph 3,
  - a. I am not an employee of any district school board or school authority, or if I am, I have taken an unpaid leave of absence as provided for by section 30 of the *Municipal Elections Act, 1996*.
  - b. I am not a clerk, treasurer, deputy clerk, or deputy treasurer of a municipality or upper-tier municipality, all or part of which is included in the area of jurisdiction of a district school board or school authority, or if I am, I have taken an unpaid leave of absence as provided for by section 30 of the *Municipal Elections Act, 1996*.
  - c. I am not a member of the Assembly as provided in the *Legislative Assembly Act* or the Senate or House of Commons of Canada, or, if I am such a person, I will provide proof of my resignation to the Clerk prior to 2:00 p.m. on Nomination Day, August 21, 2026.
  - d. I am not a Crown employee within the meaning of the *Public Service of Ontario Act, 2006* or if I am a Crown employee, I have followed and will continue to follow all relevant provisions of Part III of such Act.

5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996*, and
  - a. I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
  - b. I am not a corporation.
  - c. I am not a person acting as executor or trustee or in any other representative capacity, except as a voting proxy in accordance with section 44 of the *Municipal Elections Act, 1996*.
  - d. I am not a person who was convicted of a corrupt practice described in subsection 90(3) of the *Municipal Elections Act, 1996*, from voting in a municipal election.
6. I am not a candidate who was convicted of a corrupt practice under the *Municipal Elections Act, 1996* or of an offence under the Criminal Code (Canada), in connection with an act or omission with respect to a municipal election during the last two regular elections prior to Monday, October 26, 2026 [subsection 91(1)].
7. I am not disqualified from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the *Municipal Elections Act, 1996*, section 88.23.

AND I make this solemn declaration believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the *Canada Evidence Act*.
