BY-LAW NO. 1983-022

THE CORPORATION OF THE CITY OF OWEN SOUND

A BY-LAW OF THE CORPORATION OF OWEN SOUND TO AUTHORIZE THE ISSUE OF PERMITS FOR THE MOVING OF LARGE OBJECTS OTHER THAN BUILDINGS WITHIN THE CORPORATE LIMITS OF THE CITY OF OWEN SOUND

WHEREAS The Highway Traffic Act, R.S.O. 1980, Chapter 198, Section 93 provides that municipal corporations may grant permits for the moving of large objects and loads in excess of the limits set out in Section 92 and Part VII of the said Act;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF OWEN SOUND ENACTS AS FOLLOWS:

- 1. No person shall move on any highway under the jurisdiction of the Corporation of the City of Owen Sound any large object or load (other than buildings) in excess of the limits as set out in The Highway Traffic Act, R.S.O. 1980, Chapter 198, without first obtaining a permit therefor.
- 2. Application for the moving of said objects or loads shall be made in writing on prescribed application forms.
- 3. The Applicant shall provide proof of adequate liability insurance for such moving.
- 4. The Applicant shall obtain written approval of the departments and utilities specified on the application before a permit is issued.
- 5. The Applicant may be required to furnish a bond to cover the cost of repairing any possible damage to City property.

- 6. Moving permit fees shall be as set out in the Fees and Charges By-law, as amended from time to time.
- 7. Every person found guilty of an offence under this by-law is liable to a fine of not less than \$100.00 and not more than \$500.00.
- 8. The Chief Building Official of the City of Owen Sound is hereby appointed as the Officer having jurisdiction to issue permits as required under this by-law.
- 9. This by-law shall come into full force and effect upon the final passing thereof.
